

**** VALUE CHARGES FOR EXPRESS RATES ****

Eff. 7/1/2010

1. FOR WEIGHTS WITH LESS THAN 100 POUNDS: subtract \$50.00 from the declared value and follow the chart below for the remainder.
2. FOR WEIGHTS OVER 100 POUNDS: divide the weight by 2, subtract your answer from the declared value and use the chart below.

**** BEAVER EXPRESS WILL NOT PAY OVER \$50 IN CASE OF LOSS OR DAMAGE (OR 50 CENTS PER POUND FOR ANY SHIPMENT IN EXCESS OF 100 POUNDS) UNLESS A GREATER VALUE IS DECLARED ON THE EXPRESS BILL OR THE BILL OF LADING.**

NOTE: To determine value charges for any declared value over \$2,000.00:

1. FOR WEIGHTS UNDER 100 POUNDS: subtract \$50.00 from the declared value, then multiply the answer times 0.0065.
2. FOR WEIGHTS OVER 100 POUNDS: divide the weight by 2, subtract your answer from the declared value, then multiply your answer times 0.0065.

EXAMPLE: \$3,750 declared value, shipment weight is 125 pounds.

Divide 125 by 2 = \$62.50 (that determines the automatic value coverage @ \$0.50 per pound)
\$3,750 - \$62.50 = \$3687.50 of excess value X .0065 = \$23.97 value charge.

THE CHARGE FOR HAZARDOUS MATERIAL SHIPMENTS WILL BE \$10.00 PER SHIPMENT

**** C.O.D. SERVICE CHARGE ****
APPLICABLE FOR ALL SHIPMENTS

THE CHARGES FOR COLLECTING AND REMITTING THE AMOUNT COLLECTED ON C.O.D. SHIPMENTS WILL BE AS FOLLOWS:

ONE PERCENT (1%) OF THE C.O.D. AMOUNT COLLECTED, SUBJECT TO A MINIMUM C.O.D. SERVICE CHARGE OF \$9.00

WHEN THE AMOUNT COLLECTED IS NOT OVER \$900.00, THE CHARGE FOR COLLECTING WILL BE \$9.00

EXAMPLES EXCEEDING \$900.00

\$911.00 = \$9.11

\$965.25 = \$9.65

\$2,689.78 = \$26.90

NOTE: If, after a C.O.D. shipment has been forwarded, and the Shipper requests:

- A. That the amount of the C.O.D. be increased or decreased, or;
- B. That the Shipper will accept the Consignee's business or personal check, instead of cash or certified funds, or;
- C. That the C.O.D. amount be dropped, or;
- D. That the shipment be reconsigned to another business in the same town,

The Shipper must furnish appropriate instructions to the origin service center or independent contractor. Once approved at the origin point, the instructions will be transmitted to the destination point. A charge of \$5.00 will be made for approving and transmitting the above instructions.
